† Tribute Gift

Did you know you could honor your grandmother's birthday with a gift to Gesu's Endowment Fund? You can make a tribute gift in honor or in memory of any loved one or friend through one-time or recurring gifts. Gifts can also be given to honor a special event or occasion, such as First Communion, Baptism, Ordination, Mother's Day, graduation, or a wedding anniversary.

† Simple Gift

Perhaps you are looking to make a gift today. Gesu's Endowment Fund can accept a gift of cash or appreciated securities at any time throughout the year. We are grateful for your generosity and welcome you to contact Gesu Church with any questions.

Gifts for the Future

Gesu Church believes in strengthening our parish for future generations. Your thoughtful gift today can create a lasting legacy and provide income for Gesu Church long into the future.

† Permanent-Named Fund

With a gift of \$10,000 or more, you may name a fund for your family, for a loved one or for a charitable cause your family supports. A Permanent-Named Fund provides resources for parish priorities as identified by Gesu Church. You have the option to restrict distributions from the fund for a particular parish ministry. A Permanent-Named Fund can be created during your lifetime or funded through your estate plan.

Example:

John Jones contributes \$500 annually to Gesu Church. John wants to provide for ongoing support after his death. By establishing a Permanent-Named Fund with a bequest of \$10,000, Gesu Church will receive an annual distribution of 5% of the fund value, approximately \$500, in this example, into perpetuity.

† Charitable Lead Trust

You transfer assets to fund a lead trust that makes annual payments to our parish for a number of years. At the end of the term, your family receives the assets plus any additional value. A Charitable Lead Trust can be an effective way to transfer assets to children or grandchildren at a minimal tax cost. Your professional advisors can help you determine if this more complex estate planning vehicle makes sense for you and your family.
